B'DOS' ROLE IN ILO RECOGNIZED AT 11TH MEETING OF MINISTERS OF LABOUR

Barbados has come in for praise for its work with the International Labour Office (ILO) over the years.

The plaudits came on Tuesday as ILO's Director-General, Guy Ryder, announced 2019 as "a special year for the ILO and for its relationship with the Caribbean" during the opening ceremony of the 11th ILO Meeting of Caribbean Ministers of Labour at Accra Beach Hotel and Spa.

Commending Barbados for hosting the event, Mr. Ryder noted that this year would mark the 100th anniversary of the ILO, and also the 50th anniversary of the ILO's Caribbean office in Port-of-Spain.

Acknowledging that the biennial ministerial meeting, convened since 2003, was an important date in the ILO's calendar, and an equally important instrument for the strengthening and consolidation of cooperation, he added: "I am convinced of the significant role, both of the ILO in the Caribbean sub region and the Caribbean in the ILO, where it is today most ably represented in our governing body by the Government of Barbados, and in the workers' and employers' groups as well. I must say that today's representation follows in the path of Barbadian greats who have truly marked the 100-year history of the ILO."

Reminiscing on the role Barbados played in aiding his early development in the ILO, the Director-General stressed: "I received a good part of my training and education from Sir Frank Walcott, a number of years ago. I got my education from him, but I got my instruction from Sir Roy Trotman for many years.

"It was a different but equally valuable experience and I think we should remember as well other great Barbadians who graced our Committee of Experts - Sir Grantley Adams, himself, and Sir William Douglas, who I also had the pleasure of working with. So, today's representatives are truly standing on the shoulders of the giants of the past."

Mr. Ryder also underscored the importance of social dialogue to the ILO and its Caribbean members, highlighting Barbados' own understanding of this. He said the notion of social partnership, the collective representation of interest by employers and workers, and their interaction with government in processes of partnership, was fundamental.

"The ILO's global commission says that these partnerships and this representation of interest should be considered as a public good," he stressed.

"Something which is good not just for the worker or the employer, but good for the cohesion and good for the welfare of society as a whole. And, we believe and we take inspiration from the example of Barbados, that these notions of partnership need to be promoted as a matter of public policy around the world, and that we will all be better off as a result of so doing," he stated.

The May 14 to 15 meeting was held under the theme: Shaping A Brighter Future of Work For The Caribbean. (JG/BGIS)

PORT HEALTH NEEDS TO BE A SEPARATE ENTITY

Minister of Health and Wellness, Lt. Col. Jeffrey Bostic, wants to see the Port Health Section of the Ministry of Health established as a separate entity.

Speaking at a port health seminar for public health nurses and doctors at the Radisson Aquatica Hotel today, the minister noted that at the moment the port health service was "a bit ad hoc", explaining that it was staffed by the same doctors, nurses and environmental health officers who worked in the polyclinic system.

He stated: "I think the time has come, given the vulnerabilities that we are exposed to as a small island developing state, that we need to establish a specialized port health entity that would be part of a national border security apparatus, which ought to also involve Customs and Immigration, because you need all the eyes and the ears that we can get to be able to provide proper surveillance."

Minister Bostic said that he was proposing that the entity should be able to stand on its own so that "if there is an incident at one of the ports of entry, responding to that incident by port health officials would not impact in a negative way on the remainder of the public health sector".

"It is a highly specialized area that requires its own focus, that requires its own staff complement, its own equipment and I think that is how any national security entity, which I consider port health to be, ought to be treated," he argued.

Lt. Col. Bostic further submitted that the ports of entry needed to share in the cost of port health services.

"I believe the Ministry of Health and Wellness has a responsibility to the country to make sure that the officers have all the equipment that they require in terms of providing health care and being able to do the surveillance. But at the ports of entry I think that those entities need to take greater responsibility for providing the infrastructure that would facilitate the performance of the duties of the port health staff.

"For example, the provision and maintenance of a quarantine station has to be the responsibility of the ports of entry and also transportation to get the officers to vessels or aircraft."

Minister Bostic said that he had already started discussions with the ministers responsible for the airport and the seaport in respect of this matter.

He assured the port health workers: "Nothing is going to happen until it is discussed with you, so that you have an input and can share your views. Even if you do not agree with the establishment of a separate entity, and I will not fault you if you don't agree, I'm not going to impose my belief, at least collectively we can come up with a plan to enhance, not only the performance, but to strengthen the organization of the port health officers at the ports of entry." BURST MAIN REPAIRS AFFECTING SOME ST. MICHAEL AND CHRIST CHURCH DISTRICTS

The public is advised that as a result of the Barbados Water Authority (BWA) carrying out repairs to a 9-inch main at Belle Gully today, some St. Michael and Christ Church districts may experience water outages or low pressure.

ADD: BURST MAIN REPAIRS AFFECTING SOME ST. MICHAEL AND CHRIST CHURCH DISTRICTS - 1

Those areas in St. Michael which may be affected are: Haggatt Hall, St. Barnabas, The Pine, Wildey, Clapham, Flagstaff, Highgate and surrounding districts. In Christ Church those areas are: Fort George Heights, Upton and surrounding districts.

While repairs have been completed and the water has been turned back on, the authority's tanker crews will be dispatched to the affected areas to assist customers until the water supply is back to normal.

The BWA is also carrying out repairs to a burst main in Bush Hall Yard Gap, St. Michael, as well as investigations into reports of suspected burst mains in Massiah Street and Rosegate, St. John; and the Crane and Dodds in St. Philip. Crews are also addressing reports of low water pressure in Harrises, St. Lucy.
