CRITERIA FOR RELIEF - HOUSEHOLD EXEMPTIONS

Instructions to Applicants: Please read the information provided below **BEFORE** completing the application form.

1. SENIOR CITIZENS

The Senior Citizen GSC Exemption entitles seniors aged 65 or over, residing in their own residence with separate metered water service for that residential unit, to a reduction\waiver from payment of the GSC for their residence. This exemption provides substantial savings to seniors.

Applicants **must meet** the following criteria to be eligible for a reduction\waiver in GSC:

- You must be 65 years of age or older.
- You must be the sole occupant of the residential unit.
- You must occupy the residential unit as your principal place of residence.
- You must be in receipt of in-home care from the National Assistance Board.
- The residential unit must have a separate water meter.

If you meet **all** of the above criteria and wish to apply, you must submit an application to the GSC Relief Board. Note that you will be asked to provide the following documentation:

- Proof of age in the form of a piece of Government Issued Identification (National Identification Card, Valid Driver's License, Valid Passport).
- Proof of ownership of the residential unit in the form of a conveyance or in the case of a tenant a signed written rental agreement.
- In cases where persons who do not own the home, proof of residency is required (A utility bill in the occupant's name and the water bill in the homeowner's name).

2. FAMILIES RECEIVING WELFARE ASSISTANCE

The Welfare Assistance GSC Exemption entitles families that receive assistance from the welfare department, residing in their own residence with separate metered water service for that residence, to a reduction\waiver from payment of the GSC for their residence. This exemption provides substantial savings to the individual and to families.

Applicants **must meet** the following criteria to be eligible for a reduction\waiver in GSC:

- You or your family must be receiving assistance from the Welfare Department.
- You must occupy the residence as your principal place of residence.
- The residence must have a separate water meter.

If you meet **all** the above criteria and wish to apply, you must submit an application to the GSC Relief Board. Note that you will be asked to provide the following documentation:

- Documentation from the Ministry of People Empowerment and Elder Affairs outlining the benefits being received by your family.
- The number of persons occupying in the residential unit.
- Documentation of the income of the persons occupying the residential unit.
- Proof of ownership of the residential unit in the form of a conveyance or in the case of a tenant a signed written tenant agreement.
- In the case of persons who do not own the home, proof of residency is required (a utility bill in the occupant's name and a recent water bill in the homeowner's name).

3. PERSONS LIVING WITH A DISABILITY

The GSC Exemption for Persons Living with a Disability entitles persons identified with the Barbados Council for the Disabled, who are sole occupants of a residence with separate metered water service for that residential unit, to a reduction\waiver from payment of the GSC for their residence. This exemption provides substantial savings to persons living with disabilities.

Applicants **must meet** the following criteria to be eligible for a reduction\waiver in GSC:

- You must be acknowledged by the Barbados Council for the Disabled.
- You must be the sole occupant of the residential unit.
- You must occupy the residential unit as your principal place of residence.
- The residential unit must have a separate water meter.

Note that you will be asked to provide the following documentation:

- Documentation from the Barbados Council for the Disabled proving your registration.
- Proof of ownership of the residential unit in the form of a conveyance or in the case of a tenant a written tenant agreement.
- In the case of persons who do not own the home, proof of residency is required (a utility bill in the occupant's name and the water bill in the homeowner's name).
