Persons **must produce the original and one copy of the documents**, whether registering for the first time, making a change to their registration or seeking to replace their Identification Card. **Persons seeking to register a child under 16 years old must produce their documents and the documents of the child.**

Documents which must be presented in support of a person's name, place of birth and date of birth include:

- i. Birth Certificate (for non-nationals who cannot produce a birth certificate, the passport and a copy of the page with the personal details will be accepted for **new registrations only**)
- ii. Registrar's Certificate (for a change of name done under the Change of Name Act)
- iii. Marriage Certificate
- iv. Registered Deed Poll
- v. Decree Absolute
- vi. Sworn Affidavit
- vii. Adopted Persons Certificate

Non-citizens are also required to bring **the original and one copy of the documents**, including the status letter, issued by the Chief Immigration Officer in support of their immigration status. Documents which must be presented in support of a person's immigration status include:

vii. CARICOM Skilled Graduate	Status Certificate
viii. Right to Establishment	Entry Permit
ix. A Special Entry Permit	Entry Permit
x. Spouse of a person with a work permit for a period in excess of 1 year	Stamp in passport indicating a period in excess of 1 year
xi. Spouse of CARICOM Skilled Graduate	Stamp in passport indicating spouse of CARICOM Skilled Graduate
xii. Reside and Work	Reside and Work Certificate

If the Immigration document is stamped in the passport, a copy of that page must also be presented.
